

INDICTMENT

The Jurors of the Grand Jury of the State of Ohio, within and for the body of the county aforesaid, on their oaths, in the name and by the authority of the state of Ohio, do find and present that

Count One

on or about the 2nd day of May, 2022, in the County of Knox, State of Ohio, TERRY T. BARKER did commit AGGRAVATED MURDER by purposely, and with prior calculation and design, causing the death of Paul Williams, contrary to and in violation of Section 2903.01(A) of the Revised Code of Ohio, and contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

SPECIFICATION AS TO COUNT ONE—R.C. 2941.145: The Grand Jurors further find and specify that TERRY T. BARKER, had a firearm, to wit: a .22 caliber semiautomatic pistol, on or about his person or under his control while committing the offense, and displayed the firearm, brandished the firearm, indicated that he possessed the firearm or used it to facilitate the offense.

Count Two

on or about the 2nd day of May, 2022, in the County of Knox, State of Ohio, TERRY T. BARKER did commit HAVING WEAPONS WHILE UNDER DISABILITY, by knowingly acquiring, having, carrying or using a firearm or dangerous ordnance, to wit: a .22 caliber semiautomatic pistol, the said TERRY T. BARKER having been convicted of an offense involving the illegal possession, use, sale, administration, distribution, or trafficking in any drug of abuse, to wit: Possession of Cocaine and Possession of Heroin on the 27th day of May, 2016 in the Court of Common Pleas, Knox County, Ohio Case No. 16CR04-0058, A FELONY OF THE THIRD DEGREE, the said TERRY T. BARKER not having been relieved from disability as provided in Section 2923.14 of the Revised Code of Ohio, contrary to and in violation of Section 2923.13(A)(3) of the Revised Code of Ohio, and contrary to the form of the Statute in such case made and provided, and against the peace and dignity of the State of Ohio.
