On Tuesday, March 25, 2025 Deputy Rosch advised me at the end of my shift that he had injured himself on-duty on Monday, March 24, 2025. Deputy Rosch advised me that toward the end of his shift, his was sitting at a computer in the patrol room on the Knox County Sheriff's Office and was attempting to add medication to evidence from a DOA report he had taken earlier in the shift. Deputy Rosch stated that while he was filling out evidence forms, he had dropped something onto the floor. Deputy Rosch stated that as he attempted to pick the items up off the floor, he lost his balance and the chair that he was sitting in slipped out from under him. Deputy Rosch stated that he fell approximately 2-3 feet to the floor and felt a pop in his left knee. Deputy Rosch stated that went home after the incident and returned to work today for his normal shift. Deputy Rosch stated that during his shift, he could feel his knee pain growing to the point that it hurts just to walk. I advised Deputy Rosch that we would speak to Lieutenant Ferenbaugh as soon as he arrived at the office about the issue.
