| <p>While on duty, I was training with Deputy Feeney. We were stationary on Columbus Road near Harcourt Road, monitoring traffic. I observed a black 2014 Volkswagen Jetta drive past with what appeared to be illegal window tint on the front windows. I pulled out and began following the vehicle. As we followed, both Deputy Feeney and I observed the vehicle swerving within its lane of travel. We continued to follow the Jetta and observed it cross over the center line. I then initiated a traffic stop at the intersection of Columbus Road and Keys Road. Upon making contact with the driver, I identified him as Doroteo Jasinto. Doroteo stated that he had been on his phone, which caused him to swerve while driving. As he explained, he raised his phone from the center console to show me. Doroteo informed me that he had just finished working at a local Mexican restaurant and was on his way home to Westerville. Deputy Feeney tested the window tint on the vehicle using a tint meter, which indicated the front windows had a tint level of 15%. Doroteo was issued a citation for Use of a Handheld Electronic Device While Driving and was given verbal warnings for Marked Lanes and Illegal Window Tint.</p> | | | | | |
