**WHAT IS THE JUNIOR FAIR LIVESTOCK SALE?**

Raising an animal as a livestock project is a valuable experience for any FFA or 4-H member. Livestock projects teach youth responsibility and help develop the character of an individual by caring for an animal. They also help youth work at personal growth and development.

Because youth are raising these animals on a small scale, costs are higher and it is hard to break even at market price. As a supporter of the Junior Fair Livestock Sale, you have the opportunity to help these FFA and 4-H members by attending the sale and purchasing their livestock projects.

The Junior Fair Livestock Sale gives these young people a chance to show a profit for their hours of hard work. The success of the sale and the support of our youth is up to all of us. The gross total for the 2024 Junior Fair Livestock Sale was over \$1,000,000.00.

When the member goes through the sale, the amount bid by the buyer is considered to be the premium. Buyers will have the option to buy and processing the animals this year. Additional “bidders” will also have the ability to “add-on” to exhibitors. The premium received for an exhibitor will be mailed to the exhibitor, in the form of direct deposit or a check, following the fair. Their money will be issued through Park National Bank.

**HOW DO YOU BUY**

Prior to the auction (starting at 7:00 a.m., Friday, July 25) new buyers will need to stop by register at the Sales Building and get a sale number(s). If you are a previous buyer, there is no need to register or check-in sale day unless you have changes to be made. As each exhibitor enters the ring the auctioneer and the ring men will assist you with your bidding. Whether or not you are successful in buying the animal, your bid is appreciated and will help the sale.

**WHAT YOU GET**

Buyers will be given a photo plaque and public recognition. And thanks to the generosity of local business donors and the Knox County Junior Fair Sales Committee, there will be a lunch provided for buyers. You will just need to show them your buyer number. Lunch will be available in the Multipurpose Building.

**TERMS OF SALE**

All buyers please confirm your purchases at the Sale Building following the sale. If possible, you are asked to pay by check, cash or credit card before leaving the fairgrounds. If you pay by Visa/Master Card debit or credit card you will be assessed a 3% fee. Your prompt payment permits timely disbursements to the Junior Fair exhibitors. ## HOW DO YOU DETERMINE WHAT YOU HAVE SPENT?

The cost to the winning bidder is the amount of the successful bid, which is a premium to the exhibitor. The winning bidder is not necessarily buying the animal, rather they are paying the exhibitor a premium for their hard work. The exhibitor then receives market price for their animal from the packer (processor). If the winning bidder wishes to keep the animal for their own consumption, they will pay the packer bid as well as any premium that they bid during the sale.

Example :

**1,300 pound market beef**

**\$1.75 per pound (\$2,275) Market Value**

**You bid \$500 as a premium to exhibitor**

**You don't want the animal — you pay \$500 and the packer pays exhibitor \$2,275**

**You do want the animal — you pay \$2,775 (\$500 bid + \$2,275 market value) + the processing costs**

Benefit of PREMIUM Sale Format: Buyer will not need to calculate their "actual" cost, it will be based solely on market value established through packer bid and the amount set as a premium to the exhibitor through bidding process.

## PACKER VS. CUSTOM PROCESSING

The highest bidder has the opportunity to indicate if they wish to take possession of the animal for their own consumption. It is the highest bidders responsibility to indicate to the cashier, immediately following the sale, their intent as to how the animal should be handled.

In the case that the highest bidder is not interested in taking possession of the animal, it will be sent to harvest and will become the possession of the packer (company who places a market value-based bid for all animals).

If the highest bidder is interested in taking possession of the animal, it is then the buyers responsibility to make arrangements with the desired slaughterhouse for processing. Your options are listed below. It is then also the buyers responsibility to pay the bid premium, packer bid, and all the meat processing fees from the processor.

## PROCESSING YOUR PURCHASE

There are several meat processing plants in the area that will process your animal for your freezer or for your business. Buyers need to make arrangements with the processor. Possible choices are:

## HOW MUCH MEAT WILL YOU GET?

FROM A PURCHASE you will receive approximately the following amount of meat—cut, well trimmed and READY FOR YOUR FREEZER.

### 1,100 Pound Beef

Steaks .....	100 lbs.
Roasts .....	150 lbs.
Ground Meat .....	100 lbs.
Lesser Cuts.....	100 lbs.
Total.....	450 lbs.

### 110 Pound Lamb

Legs.....	12 lbs.
Chops.....	14 lbs.
Shoulder.....	16 lbs.
Lesser Cuts.....	3 lbs.
Total.....	45 lbs.

### 80 Pound Goat

Legs .....	9 lbs.
Chops .....	6 lbs.
Shoulder.....	13 lbs.
Ground Meat .....	4 lbs.
Total .....	32 lbs.

Many factors affect the amount of the various meat cuts obtained from a carcass. Some of these are breed of animal, weight, sex, degree of finish and cutting method used in preparing meat for the freezer.
