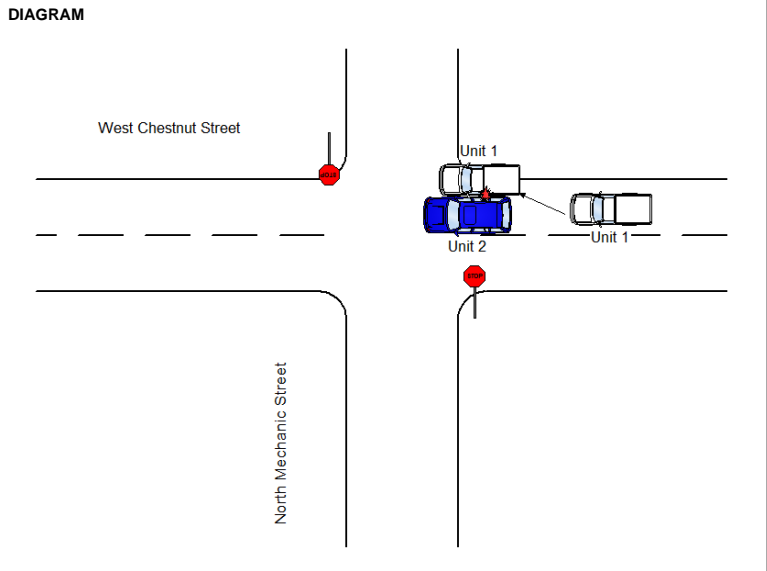

NARRATIVE
 On January 30th 2026 at approximately 4:53 P.M, I was contacted over the phone about a hit skip. Benjamin Hoar advised he was side swiped by a white work truck while driving a blue 2024 Nissan Kicks with Ohio registration JFL8291. His daughter Amelia Neitzelt was in the passenger seat. He stated he was westbound on West Chestnut Street waiting to turn south onto Mechanic Street. When traffic was backed up he decided to continue westbound, but this truck began to pass him and side swiped his vehicle causing a small amount of damage to the right side of his vehicle. He was unable to get a license plate, vehicle, or model of the vehicle that struck him.
