On Friday, February 6, 2026 Deputy Thompson 4270, while on his way home, stopped at the Town Center Apple Valley Gas Station at 21875 Coshocton Rd. Howard, OH 43028 to use the mechanical car wash. Deputy Thompson stated that after the car wash was finished, he began getting low tire pressure readings on his dash gauges advising that his passenger side front tire was loosing air. Deputy Thompson contacted me via phone advising me of the situation. I advised him to attempt to drive the vehicle back to the Knox County Sheriff's Office and park it here, in-which he was able to do so. After inspecting of the tire, we were able to locate a hole on the inside wall of the front passenger tire. I advised Deputy Thompson to take car 4201 home and leave car 4238, which belongs to the Village of Centerburg at the Office.

Deputy Thompson advised me at no time does he remember ever striking anything inside the car wash or hitting anything in the roadway, which would cause the hole in the tire.
