I confirmed a top speed of 41 mph in a posted 25 mph zone.</p> <p>As the car passed by me I turned my patrol car around and conducted a traffic stop in front of the People's Bank on Wiggin St. I made contact with the driver, Nathaniel Coker, and explained the reason for the stop. Upon my request, Nathaniel presented all proper documents. I asked Nathaniel why he was driving fast and he told me he was in a hurry to meet his girlfriend for breakfast before his college class started. Nathaniel told me that he knows what the speed limit is in the village but he just was not paying attention at that moment. Nathaniel was very polite and understanding with me.</p>
