

ORDINANCE NO. 2026-__

AN ORDINANCE TO AMEND CHAPTER 1307 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF CENTERBURG TO UPDATE THE BUILDING AND ZONING FEES

WHEREAS, Planning Commission of the Village of Centerburg has reviewed the Village’s building and zoning fees and determined that updates are necessary to more accurately reflect the costs incurred by the Village for zoning enforcement and administration; and

WHEREAS, Planning Commission conducted a public hearing on February 25, 2026, to consider the proposed revisions to the zoning fee schedule and recommended that Council adopt the updated fees; and

WHEREAS, the Planning Commission further recommended that Village Council retain sole authority to initiate and adopt future amendments to the zoning fee schedule without additional review or approval by the Planning Commission; and

WHEREAS, Council for the Village of Centerburg finds it appropriate to amend Chapter 1307 of the Codified Ordinances in accordance with the recommendations of the Planning Commission.

NOW, THEREFORE, be it ordained by the Council of the Village of Centerburg as follows:

Section 1. That **Chapter 1307. Building and Zoning Fees** is hereby amended in its entirety and made part of the Codified Ordinances for the Village of Centerburg as follows:

1307.02. This Chapter 1307 of the Codified Ordinances of the Village of Centerburg shall not be subject to the review requirements of Section 1103.07 of the Codified Ordinances. Council for the Village of Centerburg shall have the power to amend Section 1307.01 of the Codified Ordinances without prior review of Planning Commission.

WHEREFORE, this Ordinance shall take effect and be in force from and after the earliest period allowed by law after its passage and approval by the Mayor.
