<p>On June 5th, 2026 I was patrolling Martinsburg Rd near Owl Creek Church Rd facing the northbound lane. I saw the defendant's vehicle driving northbound toward my cruiser at a speed that appeared to be higher than the posted limit of 55 MPH. The patrol radar was set in moving mode as the vehicle was driving at speeds of 75, 74, 73, 72 and locked at 75 MPH coming toward me. I initiated a traffic stop with my emergency lights, and made contact with the operator Joseph M. Reitz. The defendant stated he was not paying attention to his speed, and he has a lead foot. After running the defendant's information the license plate and the vehicle did not match. The license plate JTX 8615 was registered to a 2025 white Chevy pick up with the defendant as the registered owner. I asked the defendant about it as he stated he took the plate off the Chevy and put it on the Toyota. The Chevy is broke down and he thought since it was registered to him he could put it on the Toyota. Dispatch advised that the 2006 silver Toyota does have a registered plate of KBY 6214, which expired on 6/30/2025. The defendant is the registered owner of that as-well as he claims to be selling the truck, and lost the plate. Citations were issued for speed/expired registration, as he was advised to find the plate and not to drive the vehicle until he does. The defendant</p>
