On July 30th, 2026 I was wearing the uniform of the day operating a marked Knox County Sheriff's Office patrol vehicle on Vernonview Dr. when I observed a Silver Toyota use their turn signal and pull into left turn lane in to turn into Buffalo Wild Wings, the vehicle did not turn and proceeded straight into the right hand turn lane for the backside of the Kroger parking lot before continuing into the left hand turn lane to turn into Coshocton Ave. The vehicle made a left turn into Coshocton Ave. where I activated my red and blue emergency lights to initiate a traffic stop. The vehicle stopped in front of Wendy's, I approached the vehicle introduced myself and notified the driver the reason for the stop was a marked lanes violation. I asked the driver for her license and she advised she didn't have one. I asked for her name and social which she provided, she was identified as Whitely Piatt. I asked her if she was suspended or if she never had a drivers license. She advised she was suspended, I informed her I would be right back up with her and returned to my patrol car to verify the suspension. She was currently under a license forfeiture suspension, I began issuing the citation when Sgt. Haunn arrived on scene. Sgt. Haunn took over filling out the citation while I ran my K9 around the vehicle. My K9 did not alert. I finished filling out the citation
